**IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED** that Petitioners's August ██████████ arrest and court records for the Domestic Assault and Battery in Tulsa County Case No. CM-2000-██████████, and Tulsa County case MI-2014-██████████ shall be expunged by the Oklahoma State Bureau of Investigation, the Tulsa County District Attorney, the Tulsa Municipal Prosecutor's Office, the Broken Arrow Police Department, the Tulsa County Sheriff's Office, and the Tulsa County Court Clerk, in accordance with the language of Title 22 O.S. § 19.

**FURTHERMORE**, pursuant to Title 22 O.S. § 19 (H), physical destruction of any criminal justice records is prohibited by law, and the internal records of the Tulsa County District Attorney and the internal records of the Tulsa Municipal Prosecutor's Office are not subject to this Order of Expungement. Pursuant to 22 O.S. § 19 (C) and (G), basic identification information is not subject to sealing.
