



BDA extends relocation incentive program

The Bartlesville Development Authority voted Wednesday to expand an employee relocation incentive program to a cyber security company planning to establish a local headquarters.

Pending Bartlesville City Council approval, the program will offer relocating employees of distributed cloud company HeraSoft cash assistance for purchasing or building a home in Bartlesville, rather than living in another city and commuting.

The company has established an office in the former Washington County Courthouse, where it currently has 10 employees. In the next two years, the company expects to transfer an additional 50 employees to the office.

"HeraSoft represents what could be a dream opportunity for Bartlesville: a growing need and market in cybersecurity and inbound young, bright and diverse global talent, as well as a substantial financial investment in the community with the purchase of the former county courthouse building by principles with Bartlesville roots who have consciously chosen our community for their permanent home and global headquarters," BDA President David Wood said.

More: City Council OKs affordable housing project

Inbound HeraSoft employees will be eligible for the relocation incentive of \$10,000 for purchasing a single-family home or \$20,000 for building one within Bartlesville. The program was piloted in March with a group of ConocoPhillips employees transferred to Bartlesville following the company's purchase of Concho Resources. Of the 25 employees in the group, 12 have used the incentive, Wood said.

The program is an effort by BDA to curb the loss of possible residents, and their tax dollars, to larger cities, like Owasso and Tulsa — a problem the committee has been working on since 2013.

Wood said the BDA commissioned professional market research and determined the absence of retail attractions — national brand stores, bars, restaurants, nightlife — was the primary cause, followed by the low availability of higher-end rental housing.

BDA subsequently invested in attracting retail brands, leading to the redevelopment of the Eastland, Silver Lake Village and former K-mart shopping centers.

More: Plans approved for new self-storage business in Bartlesville

The launch of the relocation incentive, and now its extension beyond the initial group of ConocoPhillips employees, is an effort to further attract home buyers. When the program was launched in March, Wood said the hope, in part, was that further interest from home buyers would encourage home development, easing Bartlesville's "acute shortage of homes."

While the supply of local housing is still well below demand, development is rebounding from 2020 lows, with the city reporting that by July 31, it issued construction permits valued \$24 million higher than the permits issued in the full year of 2020.

"Each new household is an immediate 'win,' not only from anticipated sales tax collections but also from the recognition Bartlesville will receive in the marketplace," Wood said.





The Apple iPhone 8 Plus was locked with a 4-digit PIN code. GrayKey PIN code determination was initiated on February 8, 2022 and was successful. GrayKey determined the PIN code was 9008. The iPhone was examined and the following extractions were performed:

- GrayKey Full File System Extraction
- Cellebrite UFED4PC Advanced Logical Extraction
- Cellebrite UFED4PC SIM card Extraction (Partition 1 and 2)

During the SIM card extraction, a message was displayed that the SIM had a PIN/PUK. The PIN/PUK was not known so the protected data was skipped and the remainder of the SIM card was processed.

The extractions were parsed using Cellebrite Physical Analyzer software and a combined Cellebrite exhibit report was produced. The Cellebrite exhibit report was copied to a USB thumb drive (Item 4) for later review by the requestor.





RE: Recent Developments

Dear Shareholder and Friend:

We felt it was important to update you regarding Michael Eric Nelson, a disgruntled former employee of the company who we know has been contacting many of our constituents over the last several weeks since his employment and relationships with all of our companies were terminated on February 24, 2019.

On the evening of February 24, 2019, Mr. Nelson was on a phone call with one of our directors. During the conversation, when it became clear to Mr. Nelson that the director was not agreeing with his arguments, Mr. Nelson got aggressive and told him "You had better get a bodyguard because I am going to come to your house and shoot you" then hung up. This conversation is documented in a police report given by the director to the Santa Barbara Sheriff's Office on February 25, 2019. Upon hearing of this, Anthem Blanchard, our CEO, immediately fired him, which was documented in writing to Mr. Nelson the following day.

Upon his termination, Mr. Nelson became very agitated, and since has been contacting directors, employees, advisors, shareholders, contractors, and other

individuals who have relationships with our companies in an attempt to create doubt and dissatisfaction by making many false allegations and spreading disparaging misinformation against the companies and its directors and officers. In the four weeks since Mr. Nelson's termination, the company's directors, executives and advisors have received over 600 pages of aggressive and threatening texts and e-mails.

Mr. Nelson has apparently also teamed up with Tom Wingert, a former disgruntled contractor, current shareholder and former director, whom the company has successfully fended off against aggressive and threatening actions by him in the past, and who has had his own police report filed against him in Oklahoma for making threats against company personnel back in December 2017.

Mr. Nelson and/or Mr. Wingert very recently sent an e-mail to an important business associate of the company who is not known to the public, or to any other person in our companies. We believe that Mr. Nelson and/or Mr. Wingert or both may have illegally hacked our CEO's communications in order to obtain this kind of information. On March 13, 2019, Mr. Blanchard's SIM was hacked for approximately 11 hours, and his Google account associated with his anthem@anthemgold.com email was also hacked on that same day. The information about this business associate was only in this one email account and would have been accessible during these breaches, so we believe this information was obtained during this hack.

Mr. Nelson has also embarked on a harassment campaign against the company's executives, board of directors, and General Counsel, all of whom over the course of three days last week, received dozens of telephone calls from spoof numbers, all made to look like numbers of Company personnel. The company's General Counsel also received one made to look like the phone number of a company unrelated to our companies, but with which the General Counsel has an independent relationship. Mr. Nelson also reached out to the CEO of that Company by e-mail.

Mr. Nelson has specifically targeted two higher wealth associates of ours, including sending one of them eleven e-mails in one day making various false claims of nefarious activities being committed by the companies, and sending over 100 texts to another one within a 24-hour period. According to one of these individuals who informed us of a telephone conversation with Mr. Wingert, Mr. Wingert tried to extort a large amount of money supposedly to "fund" a lawsuit

against the company.

More recently, we have learned that Mr. Nelson is now contacting many individuals in the community of our companies' advisors and executives and is sending them aggressive and false information. We believe he anonymously left a message with a very important client alleging securities fraud. Our investigation into the origins of that message is almost complete.

Upon hearing of this, Anthem Blanchard, our CEO, immediately fired him, which was documented in writing to Mr. Nelson the following day.

Upon his termination, Mr. Nelson became very agitated, and since has been contacting directors, employees, advisors, shareholders, contractors, and other individuals who have relationships with our companies in an attempt to create doubt and dissatisfaction by making many false allegations and spreading disparaging misinformation against the companies and its directors and officers. In the four weeks since Mr. Nelson's termination, the company's directors, executives and advisors have received over 600 pages of aggressive and throatening texts and e-mails.

Background:

- 1. Mr. Nelson was an employee of Anthem Vault, Inc. (the "Company") for approximately 6 years until his discharge, which officially occurred this afternoon although he was (apparently) advised of it via text message last evening while participating on a call with me.
- 2. I am one of 7 Directors _of the Company .
- 3. On February 24, 2019, I landed at LAX about 6:30 pm on a return trip from a business conference and received a text from Mr. Nelson asking me to give him a call about a corporate transaction the Company had entered int o. I texted him back and said I would call him after getting my luggage and car which I did commencing about 7:00 pm.

The Call:

The call commenced with pleasantries and a short discussion about where I was headed to from LAX and where Mr. Nelson was. He said he was staying with his parents in Las Vegas and I

said 1 was headed home to Santa Barbara. Following this, he launched into an agitated discussion about a transaction that one of the Company's affiliated companies had entered into which appeared to raise a substantial amount of money while at the same time he and other employees of the Company were being asked to take substantial cuts in salary because the Company did not have sufficient cash flow to continue at the current levels. I advised him that I had no personal knowledge of the transaction he was referencing and tried to get to the substance of his concerns. After listening for some time to his take on what the transaction was about, I asked him why he thought there was a problem from a legal perspective. He became even more agitated claiming that people would be going to jail. [Apparently while we were speaking he texted the CEO of the Company and demanded to know something about the transaction in a threatening manner. The CEO then apparently responded that his services were no longer required at the Company- in essence firing him on the spot.] Mr. Nelson then said something to the effect of "Oh great, now I've been fired." I said "What?" not realizing he was texting and talking to me and repeated his assertion about jail. When I responded to that assertion by saying that nothing he had said suggested anything criminal and that "no one was going to go to jail", he became incensed an said "You had better get a bodyguard because I am going to come to your house and shoot you" and hung up. I believe the call ended about 7:35 -7:45pm.

Subsequent Events:

I immediately phoned the CEO to advise/warn him about Mr. Nelson's threat and suggested that he inform our General Counsel and the other Board members which has been done. Further, Mr. Nelson was sent a letter terminating his employment for cause (copy attached) and all Board members have been advised.

Sometime after the Call, Mr. Nelson apparently realized that he had made a criminal threat against at least me and depending upon how one interprets his "You" statement others within our Company. To try to cover up his criminal act, he later created a text message suggesting that it was me who had threatened him and his family and that he was going to take legal action, etc. I responded by denying any threat to him or his family by me and repeating what he had threatened to do and said I was reporting it to the police in Santa Barbara. A copy of these messages is provided below. Red text is mine/Blue is Mr. Nelson's:

Hey mark ... I sent you a birthday text though didn't hear back ... I received an email I would like to discuss with you on the DL (downlow) privately Concerning \$3million Investment
This is Michael Nelson

Mike: just landed at LAX. Can i call when I've gotten my car?

Loi I was just at LAX not more than 3 hours ago

I'm in Vegas now Yes whenever text me

Is Vegas home now?

No I sold my Vegas loft in June Dentist and lawyers tomorrow

Where do you hang your hat?

Then San Francisco Tuesday

It came to our understanding last night, February 24, 2019, that during a telephone conversation with Mark Heatwole, a director for Anthem Vault, you directly threatened pot entially fatal violence against Mr. Heatwole, also implying that other people associated with the companies should also feel threatened. ORDER ON MOTIONS TO HOLD DEFENDANT IN CONTEMPT AND IMPOSE DAMAGES AND TO ENFORCE THE CONSENT JUDGMENT (Docs. 169, 175, 184, 186, 187)

J. GARVAN MURTHA, District Judge.

1. Introduction

On May 16, 2007, Plaintiff Damian Renzello and Defendant Michael Nelson entered an Agreement and Consent Judgment (the "Consent Judgment") prohibiting them from interfering with each other's businesses and from contacting each other, among other things. (Doc. 167.)

On September 18, 2014, Renzello moved pro se to enforce the Consent Judgment. (Doc. 169.) He alleged Nelson had posted defamatory statements online about him and his company, Porta-Rinx. Renzello also requested the Court hold Nelson in contempt and award damages. The Court instructed Renzello to serve notice to Nelson and allow Nelson thirty days to cure any non-compliance, as required by the Consent Judgment. (Doc. 174.) On November 21, 2014, Renzello filed a Certificate of Service attesting that he had served a copy of his motion on Nelson by first-class mail at the address Renzello provided in the underlying action, P.O. Box 761, Wakefield, RI 02880-0761. (Doc. 173.) That mail was not returned at that time.

At the May 7, 2015 hearing, Renzello testified Nelson has continued to post defamatory comments about Renzello and Porta-Rinx on the internet

tollowing the Consent Judgment. Renzello also alleges Nelson has detamed him in the comments section of an online "Popular Science" article devoted to his products and on numerous other websites, including a website titled "Ripoff Report." Renzello testified that he has lost business due to Nelson's comments. Customers have contacted him about his products, and often seek explanation for Nelson's online postings. Based on Renzello's testimony, the Court found Nelson, who failed to appear, had violated the Consent Judgment by posting defamatory comments concerning Renzello online. (Doc. 179.)

On July 23, 2015, all written communications and notices mailed by the Clerk's Office to Nelson between November 2014 and May 2015 were simultaneously returned as undeliverable. (Docs. 180-83.) On August 19, 2015, Renzello alleged Nelson has posted additional defamatory comments on the internet, and moved the Court to hold Nelson in contempt and to award damages. (Doc. 184.) Renzello mailed copies of his motion not to Nelson, as he had all previous notices, but to Leslie M. and Peter E. Nelson of Rhode Island (Doc. 184, at 9), presumably Defendant's relatives. On August 31, 2015, Nelson opposed Renzello's motion (Doc. 188) and filed his own motions to enforce the Consent Judgment against Renzello on the basis that Renzello contacted and defamed him (Docs. 186, 187).

II. Discussion

A. Renzello's Motion for Contempt Sanctions (Doc. 184)

The Federal Rules of Civil Procedure require motions be served on "every party." Fed. R. Civ. P. 5(a)(1)(D). Renzello served his motion for contempt sanctions on apparent relatives of Nelson, not on Nelson himself, and therefore service was invalid. Accordingly, the Court dismisses Renzello's motion (Doc. 184) without prejudice to renew for improper service.

B. Vacating the Order Enforcing the Consent Judgment (Does. 175, 179)

Nelson's filing indicates he received neither notice that Renzello believed he had violated the Consent Agreement nor notice of the hearing before the Court. (Doc. 188.) This is consistent with the return of his mail to the Clerk's Office as undeliverable. The Court takes notice Nelson no longer receives mail at the address listed in Court records, P.O. Box 761, Wakefield, RI 02880-0761.

In opposition to Renzello's motion for contempt, Nelson contends the judgment against him (Doc. 179) is void because he never received notice of the May 7, 2015 hearing. Rule 60(b)(4) allows for the vacatur of a judgment where "the judgment is void." Fed. R. Civ. P. 60(b)(4). In assessing whether to vacate a default judgment, a "court must consider (1) whether the default was willful, (2) whether setting aside the default would prejudice the plaintiff, and (3) whether the defendant has presented a meritorious defense to the action." I.L.G.W.U. Nat. Ret. Fund v. Meredith Grey, Inc., 986 F.Supp. 816, 823 (S.D.N.Y. 1997). Here, the Court concludes Nelson did not willfully refuse to respond because the record indicates he never received notice, Renzello will not be prejudiced if the Court sets aside the judgment because he may still seek a hearing, and that Nelson may argue he did not post the content in question. The Court may vacate its judgment (Doc. 179) sua sponte, see Int'l Controls Corp. v. Vesco, 556 F.2d 665, 668 n.2 (2d Cir. 1977) (finding "the district court . . . had power to decide sua sponte whether its judgment should be vacated, provided all parties had notice, as they did here."), and now does so. The Court also denies Renzello's motion for hearing on enforcement (Doc. 175) without prejudice.

C. Nelson's Motions to Enforce the Consent Judgment and Cease Contact (Does. 186, 187)

Nelson also moves the Court to find Renzello violated the Consent Judgment and to order Renzello to cease contact. ² He fails to follow the procedures required to seek relief through the Consent Judgment, however, because he has not provided Renzello with notice and thirty days to cure any defect. He has in fact provided Renzello no notice at all. Accordingly, the Court denies his motions without prejudice. (Doc. 186, 187.)

D. Further Proceedings

The Clerk's Office shall mail copies of Nelson's filings to Renzello. The Clerk's Office shall mail to Nelson copies of the docket sheet and all pleadings docketed between September 2014 and August 2015.³

If either Renzello or Nelson wishes to enforce the Consent Judgment, they must follow the procedures set out therein: provide the other party notice of any violation and thirty days to cure. Upon a failing to cure the non-compliance, the aggrieved party may seek a hearing before this Court to enforce the Agreement. (Doc. 167-1.)

III. Conclusion

Based on the foregoing:

- (1) the Court's Order filed May 20, 2015 (Doc. 179) is VACATED;
- (2) Renzello's Motions to Enforce Judgment, Hold Defendant in Contempt, Weigh Damages, Have Friend Assist Plaintiff, Enforce No-Contact Order, and Extend No Contact Order to Unpaid Friend (Doc. 169) are DENIED without prejudice;
- (3) Renzello's Motion for Hearing on Enforcement (Doc. 175) and Motion for Contempt Sanctions (Doc. 184) are DENIED without prejudice; and
- (4) Nelson's Motions to Enforce Consent Judgment and Cease Contact (Docs. 186, 187) are DENIED without prejudice.

- 1. Because Nelson submits his opposition pro se, the Court reads it "liberally and interpret[s] [it] to raise the strongest arguments that [it] suggest[s]." McPherson v. Coombe, 174, F.3d 276, 280 (2d Cir. 1999) (internal quotations and citation omitted).
- 2. Nelson styles his motions to request other relief as well, including to take control of a website and order a psychiatric examination of Renzello. (Doc. 186, at 1.) The Court denies these requests, as even construed liberally Nelson's filing provides no reasons such relief is warranted.
- 3. Nelson asserts certain portions of his filings with the Clerk's Office are subject to confidential treatment under 40 U.S.C. § 421, but he provides no reason to warrant that treatment and the Court, upon its review, discerns no reason. Accordingly, Nelson's filings shall be public. See, e.g., Nixon v. Warner Commc'ns, Inc., 435 U.S. 589, 597 (1978) ("It is clear that the courts of this country recognize a general right to inspect and copy public records and documents, including judicial records and documents.").



Re: Demand to Cease and Desist

Dear Mr. Nelson:

Immediately prior to and since your termination on February 24, 2019, you have sent communications to directors and officers of the companies, advisory board members and consultants of the companies, among other things. Your communications make claims that the companies and certain of its officers are committing crimes, defrauding the public and stealing from the companies.

Generally, defamation entails the following:

- 1. A false and defamatory statement,
- 2. Unprivileged publication to a third party, and
- 3. Negligence or willfulness in the communication.

Communication suggesting that someone has been involved in a serious crime involving moral turpitude or felony obviously and easily falls under number 1 above. Almost everything you have said about the companies and certain of its officers falls under this category. We have proof that you have sent such communications to, among other people, advisory board members and consultants, which was certainly publication to a third party. And your communication was more than negligent, it was malicious and designed to generate negative reactions against the persons you wrote about. This is textbook defamation, and has seriously damaged the reputations of the individuals and companies you have wrote about.

In our termination letter to you, we said that we would be aggressive in pursuing such

claims. This letter serves as our final attempt to demand that you immediately cease and desist all communications with the officers, directors, employees and shareholders of Anthem Vault, Inc., AnthemGold, Inc., AG HERC, Inc. and Hercules SEZC and any public social media posts that are defamatory to the companies or their officers or directors.

I understand that you are a shareholder of Anthem Vault, AnthemGold and AG HERC and as a result have certain rights as such. However, you have also threatened litigation against the companies to various directors and officers and as a result, we have the right to demand that all communication with the companies go through me, as General Counsel of each of the companies. If you are willing to retract your statements regarding litigation in writing, we can reassess whether you are legally permitted to communicate with certain constituents.

In addition, it has recently come to our attention that you are communicating with, among others, certain consultants using an e-mail address that appears to indicate it is an anthemvault.com address. As a former employee, you must immediately cease and desist from holding yourself out as an employee, officer or any agent of any of the companies whatsoever, either by using e-mail addresses with any of the companies' names or holding yourself out as any type of agent of any of the companies. This constitutes fraudulent activity and also falsely implies that you have a current relationship with the companies, which you do not.

I am sending this letter to you via e-mail and will follow up via certified mail, return receipt requested, to the last address we have of record for you. If this address is wrong, please provide an updated address.
